ARKANSAS STATE CLAIMS COMMISSION

March 2023 Minutes

The Arkansas State Claims Commission (the "Commission") scheduled hearings for March 9–10, 2023. The Commission also scheduled a special hearing for March 2, 2023.

Special hearing scheduled for March 2, 2023

The following members of the Commission were present:

Dexter Booth Henry Kinslow, chair Paul Morris

1. Sandra McNamee v. University of Arkansas for Medical Sciences, Claim No. 230586. Claimant filed this claim against Respondent seeking damages after Claimant was assaulted while a patient at Respondent's facility. The parties subsequently filed a settlement agreement and a joint motion to approve the settlement agreement. At the hearing on the joint motion, Jonathan Hutto appeared on behalf of Claimant, and Sherri Robinson appeared on behalf of Respondent. Based upon a review of the pleadings and the law of the State of Arkansas, the Claims Commission unanimously granted the joint motion, approved the settlement agreement, and referred the \$252,500.00 award to the Arkansas General Assembly for review, approval, and placement on an appropriations bill.

Hearing scheduled for March 9, 2023

The following members of the Commission were present:

Courtney Baird Henry Kinslow, chair Sylvester Smith

1. Christine McAuliffe, as special administrator of the Estate of David Cains v. Arkansas Department of Human Services, Claim No. 220374. Claimant filed this claim against Respondent seeking damages after David Cains died while restrained at the Booneville Human Development Center. At the hearing on the claim, Joshua Gillispie appeared on Claimant's behalf, and Rich Rosen appeared on behalf of Respondent. Based upon a review of the claim file, the 27 deposition transcripts and/or summaries submitted by the parties, the witness testimony and evidence presented, the argument of the parties, and the law of the State of Arkansas, the Commission unanimously awarded the Estate a total of \$270,000.00, with additional awards of \$45,000.00 each to Christine McAuliffe and Charlene Robinson and \$30,000.00 to Ashley Cains, for a total award of \$390,000.00.

Hearings scheduled for March 10, 2023

The following members of the Commission were present:

Courtney Baird Henry Kinslow, chair Sylvester Smith

1. *Tyler Klingensmith v. Arkansas Division of Correction*, Claim No. 210664. Claimant filed this claim seeking damages related to lost property. At the hearing on the claim, Claimant did not appear. Thomas Burns appeared on behalf of Respondent. Following confirmation by Commission staff that notice of the hearing was emailed to Claimant on November 9, 2022, at the email address provided by Claimant on the complaint form, the Commission unanimously dismissed Claimant's claim without prejudice for failure to prosecute.

- **2.** *Malik Muntaqim v. Arkansas Division of Correction*, Claim No. 220296. [hearing removed from the docket prior to March 10]
- 3. Barry Turner v. Arkansas Division of Correction, Claim No. 180886. [hearing continued]
- **4.** *Aaron Rutherford v. Arkansas Division of Correction*, Claim No. 230283. Claimant filed this claim seeking damages related to money being taken from his ADC trust fund account. At the hearing on the claim and the Respondent's motion for continuance, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the argument of the parties and the law of the State of Arkansas, the Commission placed the claim in abeyance for a period of 60 days and instructed the parties to notify the Commission if a resolution is reached.
- **5.** *Roy Hoggard II v. Arkansas Division of Correction*, Claim No. 210188. Claimant filed this claim seeking damages related to Respondent's actions following Claimant's medical procedure. At the hearing on the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon a review of the claim file, the witness testimony and evidence presented, the argument of the parties, and the law of the State of Arkansas, the Commission unanimously awarded Claimant \$200.00 in damages.
- 6. *Billy Mack Nichols Jr. v. Arkansas Division of Correction*, Claim No. 220937. Claimant filed this claim seeking damages related to the denial of a prescribed wheelchair escort to the shower. At the hearing on the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon a review of the claim file, the witness testimony and evidence presented, the argument of the parties, and the law of the State of Arkansas, the Commission unanimously awarded Claimant \$75.00 in damages.
- **7.** *Rhoda Washington v. Arkansas Division of Correction*, Claim No. 221385. Claimant filed this claim seeking unspecified damages related to damage to her vehicle. At the hearing on the claim, Claimant did not appear. Thomas Burns appeared on behalf of Respondent. Following confirmation by Commission staff that notice of the hearing was emailed to Claimant on December 28, 2022, at the email address provided by Claimant on the complaint form, the Commission unanimously dismissed Claimant's claim without prejudice for failure to prosecute.
- 8. *Ricky Scott v. Arkansas Division of Correction*, Claim No. 210588. Claimant filed this claim seeking damages related to the revocation of his hobby craft card. At the hearing on Claimant's motion to compel and motion for default judgment, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motions and responses, the argument of the parties, and the law of the State of Arkansas, the Commission unanimously granted Claimant's motion to compel and directed Respondent to provide responses to Claimant's discovery requests within 30 days. The Commission declined to rule on Claimant's motion for default judgment.
- **9.** (Other Agency Business) The Commission reviewed and approved the entry of proposed orders numbered 1-94 on Exhibit A to these minutes without discussion.

This completed all of the business on the March 2023 Claims Commission docket.
