1. *Terry Armstrong v. Arkansas Department of Transportation*, Claim No. 221166. [continued by agreement of the parties prior to hearing]

- **1.** *Andrea Young v. Arkansas Department of Transportation*, Claim No. 230629. [continued by agreement of the parties prior to hearing]
- 2. Brett Gendreau v. Arkansas Department of Transportation, Claim No. 230165. Claimant filed this claim after his vehicle was damaged by gravel. At the hearing on Claimant's claim and Respondent's pending motion, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was emailed to Claimant at the email address provided by Claimant on his claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- **3.** *Roy Sanders and Latecia Glover v. Arkansas Department of Transportation*, Claim No. 230176. Claimants filed this claim after their vehicle was damaged. At the hearing on Claimants' claim and Respondent's pending motion, Claimants failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was mailed to Claimants at the address provided by Claimants on the claim form and emailed to Claimants at an email address that Claimants used to communicate with Commission staff, the Commission unanimously voted to dismiss Claimants' claim without prejudice for failure to prosecute.
- 4. *Melinda Short v. Arkansas Department of Transportation*, Claim No. 230087. Claimant filed this claim regarding damage to her property. At the hearing on Respondent's motion to dismiss, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was mailed to Claimant at the address provided by Claimant on her claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- **5.** *Nicole Jones v. Arkansas Department of Transportation*, Claim No. 230201. Claimant filed this claim regarding damage to her vehicle. At the hearing on Respondent's motion to dismiss, Claimant appeared *pro se*, and Amanda Andrews appeared on Respondent's behalf. This hearing was a continuance of the February 9, 2023, hearing, which was continued to allow Claimant to clarify the two incidents that caused damage to her vehicle. Based on a review of the claim file, the argument of the parties, and the law of the State of Arkansas, the Commission unanimously dismissed Claimant's claim as to the first incident but found that the portion of Claimant's claim related to the second incident should not be dismissed. The Commission also put the claim in abeyance for 90 days to allow Claimant to file a claim under her insurance.

- 6. *Kenderrius Ivory v. Arkansas Department of Transportation*, Claim No. 230057. Claimant filed this claim regarding damage to his vehicle. At the hearing on the claim and Respondent's pending motion, Claimant appeared *pro se*, and Trella Sparks appeared on Respondent's behalf. The Commission unanimously voted to place this claim in abeyance for 90 days to allow Claimant to file a claim under his insurance.
- 7. Beverly Bridges v. Arkansas Department of Transportation, Claim No. 221162. Claimant filed this claim after her vehicle was damaged by paint. At the hearing on Respondent's motion for summary judgment, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was emailed to Claimant at the email address provided by Claimant on her claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- 8. *Charles Digiacomo v. Arkansas Department of Transportation*, Claim No. 221259. Claimant filed this claim after his vehicle was damaged. At the claim hearing, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was emailed to Claimant at the email address provided by Claimant on his claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- **9.** Luther McCoy Jr. v. Arkansas Department of Transportation, Claim No. 221431. Claimant filed this claim regarding damage to his vehicle. At the hearing on the claim, Claimant appeared *pro se*, and Trella Sparks appeared on Respondent's behalf. The Commission unanimously voted to place this claim in abeyance for 90 days to allow Claimant to file a claim under his insurance.
- **10.** *Tommy C. Rutherford v. Arkansas Department of Transportation*, Claim No. 200048. Claimant filed this claim after his vehicle was damaged. At the hearing on the claim and Respondent's pending motion, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was mailed to Claimant at the address provided by Claimant on his claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- **11.** *Gerald Johnson v. Arkansas Department of Transportation*, Claim No. 221437. Claimant filed this claim seeking reimbursement for trees cut down on his property. At the hearing on the claim, Claimant appeared *pro se*, and James E. Patrick appeared on Respondent's behalf. Based on a review of the claim file, the testimony and evidence presented by the parties, and the law of the State of Arkansas, the Commission unanimously voted to deny Claimant's claim.
- **12.** *Pamela G. Harris v. Arkansas Department of Transportation*, Claim No. 230089. Claimant filed this claim after her vehicle was damaged. At the claim hearing, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was emailed to Claimant at the email address provided by Claimant on her claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- **13.** *Steven Porter v. Arkansas Department of Transportation*, Claim No. 230624. Claimant filed this claim after his vehicle was damaged. At the claim hearing, Claimant failed to appear. Counsel for Respondent was present. Following confirmation by Commission staff that the hearing letter was emailed to Claimant at the email address provided by Claimant on his claim form, the Commission unanimously voted to dismiss Claimant's claim without prejudice for failure to prosecute.
- **14.** *Jaryel Jackson and Ivona Jackson v. Arkansas Department of Transportation*, Claim No. 221258. Claimants filed this claim after their vehicle was damaged by a pothole. At the claim hearing, Sheila Campbell appeared on behalf of Claimants, and Amanda Andrews appeared on Respondent's behalf. Based upon a review of the claim file, the testimony and evidence presented by the parties, and the law of the State of Arkansas, the Commission unanimously awarded Claimants \$1,000, representing Claimants' collision coverage deductible.
- **15.** *Rebecca Stephens v. Arkansas Department of Transportation*, Claim No. 230425. Claimant filed this claim after her vehicle was damaged. At the claim hearing, Claimant appeared *pro*

se, and James Patrick appeared on Respondent's behalf. Claimant requested a continuance due to her recent release from the hospital, and Respondent objected. The Commission voted unanimously to grant Claimant's continuance request.

16. (Other Agency Business) The Commission reviewed and approved the entry of proposed orders numbered 1-33 and 35-102 on Exhibit A to these minutes without discussion.
