ARKANSAS STATE CLAIMS COMMISSION

September 2023 Minutes

The Arkansas State Claims Commission (the "Commission") scheduled hearings for September 22, 2023.

The following members of the Commission were scheduled to be present:

- 1. Barry Turner v. Arkansas Division of Correction, Claim No. 180886. Claimant filed this claim seeking damages related to lost property (the "Lost Property Claim") and alleged violations of procedures regarding 48-hour relief periods from punitive segregation (the "Punitive Segregation Claim"). At the hearing on the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon a review of the claim file, the witness testimony and evidence presented, and the law of the State of Arkansas, the Commission awarded Claimant \$595.00 in damages for his Lost Property Claim and dismissed Claimant's Punitive Segregation Claim.
- 2. Billy Brooks v. Arkansas Division of Correction, Claim No. 220455. Claimant filed this claim seeking damages related to denial of yard call. At the hearing on Respondent's motion to deem admitted its requests for admission propounded to Claimant and Claimant's "Motion of Requests for all Records of Yard Call and Employees on Duty and Reasons Not Given for Yard or Required Rights from 1-2021 to 11-21[,]" Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motions and responses, the argument of the parties, and the law of the State of Arkansas, the Commission gave Claimant twenty (20) days from the date of the order to submit properly amended responses to the requests for admission and directed Respondent to provide Claimant's yard call records from January 2021 to November 2021 within thirty (30) days of the date.
- **3.** *Billy Brooks v. Arkansas Division of Correction*, Claim No. 220981. Claimant filed this claim seeking damages related to sewer water dripping into his cell. At the hearing on Respondent's motion to deem admitted its requests for admission propounded to Claimant, Claimant appeared pro se, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motion and response, the argument of the parties, and the law of the State of Arkansas, the Commission gave Claimant twenty (20) days from the date of the order to submit properly amended responses to the requests for admission.
- 4. Malary Dulaney v. Arkansas Division of Correction, Claim No. 211283. Claimant filed this claim seeking damages related to Respondent's alleged failure to provide reimbursement for property damaged by another inmate. At the hearing on Claimant's motion to compel, motion to submit subpoenas and motions for judgment and order, as well as Respondent's motion seeking to deem admitted its requests for admission propounded to Claimant and motion for sanctions, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motions and responses, the argument of the parties, and the law of the State of Arkansas, the Commission granted Claimant's motion to compel in part and directed Respondent to produce certain documents, denied Respondent's motion to deem requests for admission admitted, denied Claimant's motion to submit subpoenas, denied Respondent's motion for sanctions and responses for judgment and order.
- **5.** *Leundra Davis v. Arkansas Division of Correction*, Claim No. 201177. Claimant filed this claim seeking damages related to lost property. At the hearing on the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon a review of the claim file, the witness testimony and evidence presented, and the law of the State of Arkansas, the Commission awarded Claimant \$241.00 in damages.
- 6. *Michael Todd v. Arkansas Division of Correction*, Claim No. 221393. Claimant filed this claim seeking damages related to another inmate stabbing him. At the hearing on the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon

a review of the claim file, the witness testimony and evidence presented, and the law of the State of Arkansas, the Commission awarded Claimant \$7,503.00 in damages. The Commission also denied Respondent's motion for protective order as moot and denied Claimant's motion to subpoena documents.

- 7. *Clifton Thompson v. Arkansas Division of Correction*, Claim No. 220857. Claimant filed this claim seeking damages related to Respondent's mailroom employees destroying Claimant's family photos. At the hearing on Respondent's motion to deem admitted its requests for admission propounded to Claimant and motion for protective order, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motion and response, the argument of the parties, and the law of the State of Arkansas, the Commission gave Claimant twenty (20) days from the date of the order to submit properly amended responses to the requests for admission and granted Respondent's motion for protective order. The Commission deemed Claimant's requests for admission within thirty (30) days of the order.
- 8. John Noonan v. Arkansas Division of Correction, Claim No. 220738. Claimant filed this claim seeking damages related his stimulus payments from the federal government. At the hearing on Respondent's motion for summary judgment, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motion and response, the argument of the parties, and the law of the State of Arkansas, the Commission dismissed Claimant's claim.
- **9.** *Patrick Sherman v. Arkansas Division of Correction,* Claim No. 230131. Claimant filed this claim on July 28, 2022. On September 20, 2022, the Commission requested briefs from the parties on the issue of whether Claimant's four most recent claim filings (Claim Nos. 230131, 230132, 230133, and 230388) constituted an abuse of process pursuant to Ark. Code Ann. § 19-10-221. At the hearing on the abuse of process issue, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the parties' briefs, the argument of the parties, the records of the Commission, and the law of the State of Arkansas, the Commission dismissed Claimant's claim pursuant to Ark. Code Ann. § 19-10-221.
- **10.** *Patrick Sherman v. Arkansas Division of Correction,* Claim No. 230132. Claimant filed this claim on July 28, 2022. On September 20, 2022, the Commission requested briefs from the parties on the issue of whether Claimant's four most recent claim filings (Claim Nos. 230131, 230132, 230133, and 230388) constituted an abuse of process pursuant to Ark. Code Ann. § 19-10-221. At the hearing on the abuse of process issue, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the parties' briefs, the argument of the parties, the records of the Commission, and the law of the State of Arkansas, the Commission dismissed Claimant's claim pursuant to Ark. Code Ann. § 19-10-221.
- **11.** *Patrick Sherman v. Arkansas Division of Correction,* Claim No. 230133. Claimant filed this claim on July 28, 2022. On September 20, 2022, the Commission requested briefs from the parties on the issue of whether Claimant's four most recent claim filings (Claim Nos. 230131, 230132, 230133, and 230388) constituted an abuse of process pursuant to Ark. Code Ann. § 19-10-221. At the hearing on the abuse of process issue, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the parties' briefs, the argument of the parties, the records of the Commission, and the law of the State of Arkansas, the Commission dismissed Claimant's claim pursuant to Ark. Code Ann. § 19-10-221.
- **12.** *Patrick Sherman v. Arkansas Division of Correction,* Claim No. 230388. Claimant filed this claim on September 17, 2022. On September 20, 2022, the Commission requested briefs from the parties on the issue of whether Claimant's four most recent claim filings (Claim Nos. 230131, 230132, 230133, and 230388) constituted an abuse of process pursuant to Ark. Code Ann. § 19-10-221. At the hearing on the abuse of process issue, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the parties' briefs, the argument of the parties, the records of the Commission, and the law of the

State of Arkansas, the Commission dismissed Claimant's claim pursuant to Ark. Code Ann. § 19-10-221.

- **13.** *Kwasi McKinney v. Arkansas Division of Correction*, Claim No. 200909. Claimant filed this claim seeking damages related to lost property. At the hearing on damages, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon a review of the claim file, the witness testimony and evidence presented, and the law of the State of Arkansas, the Commission awarded Claimant \$3,155.29 in damages.
- 14. Corey Hupp v. Arkansas Division of Correction, Claim No. 221041. Claimant filed this claim seeking damages related to Respondent's employee allegedly violating policy, which resulted in Claimant being beaten and injured by other inmates. At the hearing on motion for reconsideration of the Commission's July 26, 2022, order dismissing the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motion and response, the argument of the parties, and the law of the State of Arkansas, the Commission denied Claimant's motion for reconsideration.
- **15.** *Bart Woodard v. Arkansas Division of Correction*, Claim No. 221169. Claimant filed this claim seeking damages related to Respondent's alleged omissions that resulted in another inmate raping Claimant multiple times from February 2020 to July 2020. At the hearing on Claimant's request for an exhibit filed by Respondent, which was marked Submitted in camera: DO NOT RELEASE TO INMATE[,]" Claimant appeared pro se, and Thomas Burns appeared on behalf of Respondent. Claimant viewed the exhibit during the hearing and agreed that his pending "petition for default judgment..." and "motion to prevent further delay..." were moot. Based upon the review of claim file, the argument and agreement of the parties, and the law of the State of Arkansas, the Commission denied Claimant's "petition for default judgment..." and "motion to prevent further delay..." and "motion to prevent further delay..."
- 16. Roy Hoggard v. Arkansas Division of Correction, Claim No. 220385. Claimant filed this claim seeking damages related destroyed photographs. At the hearing on Claimant's motion for summary judgment and Respondent's motion to strike, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon the review of claim file, the motions and responses, the argument of the parties, and the law of the State of Arkansas, the Commission denied Claimant's motion for summary judgment and denied Respondent's motion to strike.
- **17.** (Other Agency Business) The Commission reviewed and approved the entry of proposed orders numbered 1–168, 170–197, ADC1–ADC19, and ADC21–ADC34 as described on the attached spreadsheet without discussion.

This completed the business on the September 2023 Commission docket.
