ARKANSAS STATE CLAIMS COMMISSION

February 2024 Minutes

The Arkansas State Claims Commission (the "Commission") held hearings on February 22–23, 2024. The Commission also held a special hearing on February 8, 2024. These hearings were held via Zoom.

Special hearing scheduled for February 8, 2024

The following members of the Commission were present:

1. LaJessica Mayo-Crenshaw v. Ark. State Police, Claim No. 221049. Claimant filed this personal injury claim following an accident involving one of Respondent's troopers. The parties submitted a Release and Settlement Agreement to the Commission. Based upon a review of the claim file and the Release and Settlement Agreement, the Commission unanimously approved the Release and Settlement Agreement and referred the total award of \$30,000.00 to the General Assembly for review and placement on an appropriation bill pursuant to Ark. Code Ann. § 19-10-215(b).

- 1. Kenena Pelfrey and Douglas Pelfrey v. Ark. Dept. of Transp., Claim No. 220574. Claimant filed this claim against Respondent regarding damage to Claimant's property. At the hearing on Respondent's motion to dismiss Claimant's second amended complaint, Dylan Botteicher appeared on behalf of Claimant, and Alexander Denker appeared on Respondent's behalf. Based on a review of the claim file, the argument of the parties, and the law of the State of Arkansas, the Commission denied and dismissed Claimant's claim as time-barred.
- **2.** Antonio George v. Ark. Dept. of Transp., Claim No. 240052. Claimant filed this claim against Respondent regarding damage to Claimant's vehicle. At the hearing on Respondent's motion to dismiss, Claimant did not appear. Jay D. Wilkins appeared on behalf of Respondent. Following confirmation that notice of the hearing was transmitted to the parties on September 13, 2023, the Commission unanimously dismissed Claimant's claim for failure to prosecute.
- **3.** *Nicole Jones v. Ark. Dept. of Transp.*, Claim No. 230201. Claimant filed this claim against Respondent regarding two incidents of damage to Claimant's vehicle. At the claim hearing, Claimant did not appear. Alexander Denker appeared on behalf of Respondent. The Commission voted at the hearing to dismiss Claimant's claim for failure to prosecute if she did not contact the Commission within one week of the hearing to request a new hearing date based on the nationwide cell outage on that day. Claimant did contact the Commission, and the claim hearing was rescheduled.
- **4.** *Rodney Haag v. Ark. Dept. of Transp.*, Claim No. 220717 [removed from docket prior to hearing due to nonsuit by Claimant].

- **5.** Clementine Bass v. Ark. Dept. of Transp., Claim No. 231626. Claimant filed this claim against Respondent regarding damage to Claimant's vehicle. At the hearing on Claimant's motion for reconsideration, Claimant appeared pro se, and Jay D. Wilkins appeared on behalf of Respondent. Based upon a review of the claim file, the argument of the parties, and the law of the State of Arkansas, the Commission unanimously denied Claimant's motion for reconsideration.
- **6.** Robert Driggers v. Ark. Dept. of Transp., Claim No. 231420. Claimant filed this claim against Respondent regarding damage to Claimant's vehicle. At the hearing on Claimant's motion for reconsideration, Claimant did not appear. Jay D. Wilkins appeared on behalf of Respondent. Following confirmation that notice of the hearing was transmitted to the parties on November 29, 2023, the Commission unanimously denied Claimant's motion for reconsideration.
- 7. (Other Agency Business) The Commission reviewed and approved the entry of proposed orders numbered B1-B29 on the attached list without discussion. Following the hearing, Commission staff pulled B7 to submit a corrected version for the Commission's consideration in March 2024.
