ARKANSAS STATE CLAIMS COMMISSION

March 2024 Minutes

The Arkansas State Claims Commission (the "Commission") held hearings on March 1, 2024, and March 7–8, 2024. The March 1 hearings were held via Zoom, and the March 7–8 hearings were held in person at the Commission's offices.

Hearings scheduled for March 1, 2024 (rescheduled from February 23, 2024)

The following members of the Commission were present:

Dee Holcomb Solomon Graves Henry Kinslow, chair Sylvester Smith

<u>Note</u>: Commissioner Holcomb attended the hearings to observe, not as a member of the hearing panel.

- 1. Christine McAuliffe, as Special Adm'r of the Est. of David Cains v. Ark. Dept. of Hum. Srvs., Claim No. 220374. Claimant filed this wrongful death claim after Mr. Cains died at the Booneville Human Development Center. At the hearing on Claimant's motion to reconsider the Commission's July 1, 2023, order, Josh Gillispie appeared on Claimant's behalf, and Abbey Trussell appeared on behalf of Respondent. Based upon a review of the claim file, the argument of the parties, and the law of the State of Arkansas, the Commission denied the motion for reconsideration, such that the July 1, 2023, order remains in effect.
- **2.** *Idamarie Soto Diaz v. Ark. Dept. of Finance and Admin.*, Claim No. 230477. Claimant filed this claim after she was injured. At the hearing on Respondent's motion for summary judgment, John Pike appeared on Claimant's behalf, and Michael Harmon and Brad Young appeared on behalf of Respondent. The Commission did not hear argument on the pending motion but instead voted unanimously to place the claim in abeyance to allow Claimant to exhaust her remedies against the owner of the property.
- 3. Sebrena Westcott v. Univ. of Ark. for Medical Sciences, Claim No. 190008. Claimant filed her claim after she suffered injuries from tripping on a rug in Respondent's emergency room. At the claim hearing, Charsie Gordon appeared on Claimant's behalf, and Sherri Robinson appeared on behalf of Respondent. Based upon a review of the claim file, the testimony and evidence presented by the parties, and the law of the State of Arkansas, the Commission found that Respondent was liable for Claimant's injuries. The Commission awarded Claimant \$55,000 in lost wages, \$2,576.78 in remaining medical bill balances, and \$30,000 in pain and suffering, for a total award of \$87,576.78. The Commission will submit this award to the Arkansas General Assembly for review, approval, and placement on an appropriation bill pursuant to Ark. Code Ann. § 19-10-215(b).

Hearings scheduled for March 7, 2024

The following members of the Commission were present:

Solomon Graves Henry Kinslow Paul Morris, chair

1. Shannon Forrest, Sp. Adm'r of the Est. of Melissa Forrest v. Ark. Dept. of Transp., Claim No. 210930. Claimant filed this wrongful death after Melissa Forrest in a collision with a dump truck owned and operated by Respondent. At the claim hearing, David A. Couch appeared on Claimant's behalf, and Amanda Andrews and Alexander Denker appeared on behalf of Respondent. Based upon a review of the claim file, the testimony and evidence presented by

the parties, and the law of the State of Arkansas, the Commission unanimously voted to deny Claimant's claim based on the apportionment of fault to Ms. Forrest.

2. (Other Agency Business) The Commission reviewed and approved the entry of proposed orders numbered A1–14, B1–7, C1–14 on the attached list without discussion.

Hearings scheduled for March 8, 2024

The following members of the Commission were present:

Dee Holcomb Henry Kinslow Paul Morris, chair

- 1. Mary Ann Jones, as Special Administrator of the Estate of Oscar Odell "Bill" Jones, deceased, and on behalf of the Wrongful Death Beneficiaries of Oscar Odell "Bill" Jones v. Ark. Dept. of Veterans Affairs, Claim No. 200817. Claimant filed this claim seeking damages for the death of Mr. Jones. At the claim hearing, Jeff Priebe appeared on Claimant's behalf, and Jordan Broyles and Justin Brascher appeared on behalf of Respondent. Based upon a review of the claim file, the testimony and evidence presented by the parties, and the law of the State of Arkansas, the Commission unanimously voted to find Respondent liable for the death of Mr. Jones and awarded \$300,000 in damages (\$100,000 to Mr. Jones' Estate for loss of life damages, \$100,000 to Mr. Jones' Estate for Mr. Jones' pain and suffering and mental anguish, and \$100,000 in mental anguish damages to Mr. Jones' wife). The Commission will submit this award to the Arkansas General Assembly for review, approval, and placement on an appropriation bill pursuant to Ark. Code Ann. § 19-10-215(b).
- **2.** Arthur Carson v. Univ. of Ark. for Medical Sciences, Claim No. 230927. Claimant filed this claim seeking \$40,000 in damages from Claimant's slip-and-fall on Respondent's property. At the claim hearing, Claimant proceeded pro se, and Sherri Robinson appeared on behalf of Respondent. Based upon a review of the claim file, the testimony and evidence presented by the parties, and the law of the State of Arkansas, the Commission found that Claimant had not met his burden of proof and denied Claimant's claim.

This completed the business on the March 2024 Commission docket.
