ARKANSAS STATE CLAIMS COMMISSION

July 2024 Minutes

The Arkansas State Claims Commission (the "Commission") scheduled hearings on July 18–19, 2024 via Zoom.

Hearings scheduled for July 18, 2024

The following members of the Commission were present:

Henry Kinslow, chair Paul Morris Sylvester Smith

1. (Other Agency Business) The panel reviewed and approved the entry of proposed orders numbered B1–7 and B9–13 on the attached list without discussion. Following the hearing, Commission staff pulled B11 due to an error discovered after approval.

- 1. *Timothy Axelson v. Ark. Div. of Correction*, Claim No. 200548. [prior to the beginning of the hearing, Claimant objected to Commissioner Graves' participation on the panel, and the hearing was continued]
- 2. *Ricky Scott v. Ark. Div. of Correction*, Claim No. 210588. Claimant filed this claim seeking damages related to the revocation of his hobbycraft card. Prior to the beginning of the status conference, Claimant stated that he did not object to Commissioner Graves' participation on panel. At the status conference, Claimant appeared *pro se*, and Kris Higdon appeared on behalf of Respondent. Based upon a review of the claim file, the statements of the parties and the law of the State of Arkansas, the Commission found that the claim should be added to the hearing schedule as soon as practicable.
- 3. *Marcus Fields v. Ark. Div. of Correction*, Claim No. 181013. Claimant filed this claim seeking damages related to lost property. Prior to the beginning of hearing, Claimant stated that he did not object to Commissioner Graves' participation on panel. At the hearing on Claimant's motion for reconsideration, Claimant appeared *pro se*, and Kris Higdon appeared on behalf of Respondent. Based upon the review of claim file, the argument of the parties, and the law of the State of Arkansas, the Commission granted Claimant's motion for reconsideration and set aside its September 22, 2023, dismissal order and found that the claim should be added to the hearing schedule as soon as practicable.
- 4. *William Gullion v. Ark. Div. of Correction*, Claim No. 200217. Claimant filed this claim seeking damages related to Respondent's actions with respect to the Step Down program. Prior to the beginning of the status conference, Claimant stated that he did not object to Commissioner Graves' participation on panel. At the status conference, Claimant appeared *pro se*, and Trent Rigdon appeared on behalf of Respondent. Based upon a review of the claim file, the statements of the parties and the law of the State of Arkansas, the Commission asked the parties to notify it when the claim should be added to the hearing schedule.
- 5. James Jackson v. Ark. Div. of Correction, Claim No. 240547. Claimant filed this claim seeking damages relating to an unauthorized deduction from his inmate account. Prior to the beginning of the hearing, Claimant stated that he did not object to Commissioner Graves' participation on panel. At the hearing on the claim, Claimant appeared *pro se*, and Thomas Burns appeared on behalf of Respondent. Based upon a review of the claim file, the witness

testimony and evidence presented, and the law of the State of Arkansas, the Commission awarded Claimant \$25.00 in damages.

- 6. Steven McArthur v. Ark. Div. of Correction, Claim No. 211186. Claimant filed this claim seeking damages related to Respondent's failure to provide Claimant with a key to a locker box, which resulted in lost property. Prior to the beginning of hearing, Claimant stated that he did not object to Commissioner Graves' participation on panel. At the hearing on Claimant's to compel, Claimant appeared *pro se*, and Trent Rigdon appeared on behalf of Respondent. Based upon the review of claim file, the argument of the parties, and the law of the State of Arkansas, the Commission granted Claimant's motion to compel and directed Respondent to serve answers to requests for admission within ten days of the order.
- 7. (Other Agency Business) The panel reviewed and approved the entry of proposed orders numbered A1–56 and C1–64 on the attached list without discussion. Following the hearing, Commission staff determined that there was no A36 due to a misnumbering.
